

## **Centerville UTOPIA Fiber Utility Advisory Committee**

Macquarie Capital, a global investment bank that specializes in Public Private Partnerships (PPP) with local and regional governments to build and operate public infrastructure, is proposing a new partnership with UTOPIA Cities that would transform the network into a “Fiber Utility”.

I invite you to serve our community by participating in a UTOPIA Fiber Utility Advisory Committee, a group of residents and business owners I am asking to advise the City Council and our community on this important decision. This assignment is expected to take 1-3 months. The commitment would include reading background material, attending 2 or 3 public committee meetings to discuss the options available to Centerville, and providing feedback to the City Council to assist in their decision making responsibility. Ideally, I would like the committee to substantially complete their analysis before the City Council holds public hearings on the proposal in June.

The purpose of this committee is not to repeat well-known criticisms of Centerville’s past involvement in UTOPIA. The purpose is to assist Centerville in analyzing and evaluating the options going forward, especially the specific proposal from Macquarie for a “fiber utility”.
